No. 4/12/LA/2015-Com(Rev) : The Governor of Manipur is pleased to notify under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the land measuring 0.5785 acres of land described in the schedule annexed herewith are likely to be needed for a public purpose i.e. widening of Moirang Kampu Phaknung Road for the portion from Km. 4.50 Kangla Awang Leikai to Km. 4.96 Phaknung Makha Leikai at Village No. 36-Kangla Siphai and 35-Phaknung in Imphal East District, Manipur and that the Additional District Magistrate, Imphal East has been appointed as Administrator under section 43 of the said Act for the purposes of rehabilitation and resettlement.

Further, the Governor of Manipur is also pleased to authorize the concerned Sub-Divisional Officer(s), Sub-Deputy Collector(s), AS&SO(s) and staff under their control to take steps under the provisions of section 12 read with section 13 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to submit report to the Collector (LA), Imphal East.
