**NOTIFICATION/DECLARATION**

Imphal, the 11<sup>th</sup> July, 2016.

**No. 4/44/LA/2014-Com(Rev)** : Whereas, it appears to the Government that a total of 1.11 acres(0.4492 hectare) of land is required in 2(two) villages namely 1) 87- Huikap Village and 2) 104-Top Chingtha in Imphal East District for a public purpose i.e. construction of Right Main Canal from RD. 21.182 Km to RD. 21.440 Km of Thoubal Multipurpose Project;

2. Therefore, declaration under section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is made that land measuring 1.11 acres(0.4492 hectare) is under acquisition for the above said project in 2 (two) villages namely 1) 87 - Huikap and 2) 104 - Top Chingtha in Imphal East District and the detailed descriptions are enclosed as Annexure-A.

3. This declaration is made after hearing of objections of persons interested and due enquiry as provided under section 15 of the Right to Fair Compensation and Transparency in Land Acquisition and Resettlement Act, 2013 (30 of 2013). The number of families likely to be resettled due to land acquisition is nil as pre the report of the Collector.

4. A plan of the land may be inspected in the office of the Collector, Land Acquisition, Imphal East on any working day.
