1. After a detailed discussion it has been decided that the allocated target should be distributed on pro-rata basis as per household numbers as indicated above. The identification of beneficiaries will be carried out through joint meeting wherein Hon'ble MP/MLAs/ZPs, Pradhans/Councillors/Ward Members are represented and identification should be carried out as per the guidelines already circulated in this regard. The Hon'ble Adhyaksha, Imphal East Zilla Parishad shall inform all the PRI bodies to ensure their participation in the identification of the most deserving beneficiaries.

2. Indira Gandhi National Disable Pension Scheme: Since the scheme is based on certain criteria and it was decided not to make allocation on pro-rata basis. Accordingly, it was decided for approval of the 169 nos. of deserving disable persons having degree/percentage of disability of 90% and above from 288 nos. of identified eligible disable persons on priority. The proposal for sanctioning of the remaining 119 is to be intimated to the Social Welfare Department. The Assembly Constituency wise identified disable persons as follow:
